SAMPLE DEMAND FOR THE UNFREEZING OF SOCIAL SECURITY MONEY

Below is a sample letter you can use to mail to the **Court** and to the Plaintiff's **law firm** and to **your bank** to assert your right not to have social security money frozen to pay a judgment. If you have any questions, consult a Consumer Rights Attorney. Nothing stated herein is legal advice. For legal advice, consult an attorney.

You can copy and paste the below text into your word processor. You will have to tailor and edit the document to suit your needs.

Make sure you send the letter Certified Mail, Return Receipt Requested. Debt collectors are notorious for claiming they did not receive First Class mail.

Dear Clerk of Court:

On XXX date, I learned money belonging to me and in my bank account was frozen by the bank due to an alleged judgment and Writ of Execution issuing from this Court. The amount frozen by my bank was \$X.XX. Of that amount, \$X.XX was money I received from the Social Security Administration. Pursuant to 42 U.S.C. § 407(a), I demand that my social security money be unfrozen and demand the immediate return of the money that was frozen.

If my funds are not immediately released by court order or upon instructions from the Court or by Plaintiff's attorneys within five (5) days from the date of this

letter, I demand that an Objection Hearing be immediately scheduled. At that time, I will assert my federal rights in open Court. If applicable, please provide me with the date and time of the Objection Hearing.

The seizure of my social security money has caused me to experience severe financial distress. I have been severely inconvenienced and experienced damages as a result of this seizure. If the Plaintiff or the bank does not cause the release of my funds as demanded above, I may be forced to hire an attorney to do so.

Your time and attention to this matter is greatly appreciated. If you have any questions, comments or concerns, please contact me at the above address or call me at XXX-XXX-XXX. (You do not need to include your telephone number if you do not want to.)
